## WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in such activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.
- 3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the abovenamed RELEASEES.

I acknowledge that I will receive packets of material from The Green Legion, which includes game tickets, tailgate badges, TAP Cards (transportation), and wristbands, to the December 16<sup>th</sup> game between the Philadelphia Eagles and Los Angeles Rams. I understand and agree that the above referenced badges must be worn to every event organized by The Green Legion. Failure to do so may result in the inability to participate in these and all other activities associated with this trip.
- 6. In receipt of this packet from The Green Legion, I understand and agree that it is my sole responsibility to maintain possession of these materials. In the event of loss, whether by theft, misplacement or other means, I waive the right to bring any action, legal or otherwise, against The Green Legion. Failure to abide by any of the terms of this agreement will result in the termination of any and all of the agreements between the undersigned and The Green Legion with respect to the December 16<sup>th</sup> game between the Philadelphia Eagles and Los Angeles Rams.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
